Our primary objectives in 2010/2011, marking the beginning of a new era for our Centre, were to develop a new and sustainable organizational structure and model of client services in London and across the region, that would build upon the strengths of our existing model – and ensure successful clinical outcomes for our clients. We also wanted our structure and model to be complementary to the work of partners in London and throughout our regional offices, be viable across a range of current service delivery contexts and address future challenges that our Centre will face. - completing our program, organizational and leadership re-shaping;

- responding to the School Health Support Services Review Report and the Autism Services 'Expression of Interest';
- commencing the implementation of a new computerized clinical information system
- moving forward on the self-appraisal stage of Accreditation;
- establishing a physical link with the North Tower of London Health Sciences Centre;
- reviewing and revising our corporate bylaws to be consistent with new legislation; and
- taking care of the myriad elements of our business but especially of our clients and staff.

We are very pleased to say that, while serving over 7,000 children and youth and their families, we achieved all that we set out to do in this year. Much of what we started this year will carry over into our next fiscal year and definitely influence what we intended: strengthening our foundation to strengthen our future.



NOTE TO CONDENSED FINANCIAL STATEMENT

The accompanying condensed financial statements have been prepared by management and include certain estimates based on management judgments. These estimates affect the reported amounts of assets and liabilities at the date of the condensed financial statements and the reported amounts of revenues and expenses during the year. Actual results may differ from those estimates. In the opinion of management, the condensed financial statements have been properly prepared within reasonable limits of materiality.

The condensed financial statements are derived from and are in agreement with the audited financial statements. The condensed statements consist of major subtotals and totals from the audited financial statements and exclude certain presentation detail and disclosures required by Canadian generally accepted accounting principles.

Administrative costs are allocated to the programs based on program costs as a percentage of overall operating costs of the Centre, staffing and occupied space. Donations and grants received for specific capital purchases are recorded as deferred contributions, and brought into revenue to offset the related amortization.

These investments are subject to market value fluctuations and the Centre records these investments at fair market value. Accordingly, the year-end market values and investment income for the year include unrealized gains of \$372,522 (2010 - gains of \$969,250).


